1. Introduction

1.1 Purpose

2. Policy Principles

- Increase employee awareness and training where practically possible.
- Through this policy and our actions, we seek to protect and build the Fred's reputation across all aspects of our business.

- Fred's will identify and manage environmental aspects to:
 - Minimise greenhouse gas emissions.
 - Promote efficient use of materials and conserve resources.
 - Optimise and minimise resource consumption.
 - Protect the environment and prevent pollution.
 - Minimise waste
 - Commit to the principle of reduce, reuse and recycle.
